These terms and conditions apply to students enrolled in VET courses delivered by Taylorweir.

TERMS AND CONDITIONS OF ENROLMENT

I hereby apply to enrol in the course commencing the date indicated on the Enrolment Form.

I agree that on acceptance of the Enrolment Application by Taylorweir, the acceptance will become the Contract of Enrolment and further I agree to abide by the following terms and conditions of enrolment (includes the parent/guardian who has signed this Enrolment Application):

1. **I acknowledge** that I have read and understood the **Student Handbook**.
2. **I understand** that Tuition and Resource Fees are inclusive of tuition, learning manual, all consumable mannequins, products, and sundries used in the course.
3. **I understand that on the first day of each semester, I MUST pay for the Learning Manual. Currently the cost of the Learning Manual is \$300.00**
4. **I acknowledge** that I have read and understood the Payment of Fees Policy, Refund Policy and Procedure as outlined in the **Student Handbook**.
5. **I understand** that my enrolment is not finalised until all statutory and RTO based fees and charges are paid on commencement unless the Course Fee Payment Plan Option has been selected on enrolment.
6. **I agree** that course fee payment arrangements established during enrolment are always to be maintained
 - ♦ **I agree** that when accepting the Course Fee Payment Plan Option, all course fees are to be paid by the due dates set out in the payment plan
 - ♦ **I agree** that if I fail to adhere to the payment plan and fall behind in payments, I will not be enrolled in additional units unless I have made appropriate arrangements agreed by Taylorweir
7. **I understand** that I **must** provide my own **hairdressing/barbering equipment** and **tripod** when attending Taylorweir. **I understand** that failure to do so, will result in my employer being notified, which may result in being sent back to work.
8. **I agree** that I am required to use my best endeavours to meet the requirements of the course selected and to abide by Taylorweir Student Behaviour Standards. **I understand** that if my behaviour is deemed unacceptable by Taylorweir, my enrolment may be cancelled and I may not be entitled to any refund of the tuition fees or other charges paid to Taylorweir under the Contract of Enrolment as applicable at that time. TRAINING TERMS AND CONDITIONS

9. **I agree** that all lessons and any related material supplied by Taylorweir are copyright and remain the property of Taylorweir. **I understand** that any unauthorised copying may constitute a breach of the Copyright Act 1968 (as amended).
10. **I agree** to advise Taylorweir of any change of my address and/or contact details and change of salon/barbershop employer while I am enrolled in the course.
11. Taylorweir maintains a Privacy Policy as outlined in the **Student Handbook**. In addition to the provisions of this policy, **I authorise Taylorweir** to release administrative information concerning my performance at Taylorweir (including academic progress and attendance information) to my employer.
12. **I understand** that should a new version of the SHB National Qualification be endorsed and released by the relevant authorities, Taylorweir must manage the transition of its students to the new version in accordance with the Australian Skills Quality Authority's directions and that this circumstance does not constitute Provider Default.
